

MAXWELL HOUSE NHL® MEET & GREET CONTEST

OFFICIAL CONTEST RULES

1) WELCOME: The *Maxwell House* NHL® Meet & Greet Contest (the “**Contest**”) is sponsored and administered by Kraft Heinz Canada ULC, 95 Moatfield Drive, Toronto, ON M3B 3L6 (the “**Sponsor**”).

2) CONTEST PERIOD: The Contest begins November 1, 2020 at 12:00 p.m. (EDT) and ends March 31, 2021 at 11:59 p.m. (EDT) (the “**Contest Period**”).

3) ELIGIBILITY: The Contest is open to legal residents of Canada who have reached the age of majority in the province or territory in which they reside as of their date of entry in the Contest Period (“**Entrant**” or “**Entrants**”).

The Contest is not open to:

(a) employees, officers and directors of the Sponsor, the National Hockey League (“**NHL**”), its member clubs, NHL Enterprises, L.P., NHL Enterprises Canada, L.P., NHL Enterprises B.V., NHL Interactive CyberEnterprises, LLC, (the foregoing NHL entities collectively, the “**NHL Entities**”), the National Hockey League Players’ Association (“**NHLPA**”), its members and Hockey Ventures (Canada) Inc. (the foregoing NHLPA entities collectively, the “**NHLPA Entities**”), and their respective parents, affiliates, subsidiaries, advertising and promotion agencies, representatives or agents, as applicable (collectively, “**Promotion Parties**”); and

(b) the immediate family members (regardless of where they live) of a person excluded under (a) or anyone domiciled with a person excluded under (a) (whether related to that person or not). For the purposes of these Official Contest Rules, “immediate family” includes husband, wife, spouse, partner, mother, father, brothers, sisters, sons, and/or daughters.

4) HOW TO ENTER: NO PURCHASE NECESSARY.

(a) **REGULAR ENTRY:** To enter an Entrant must, within the Contest Period:

(i) Purchase a specially-marked *Maxwell House* NHL® Meet & Greet Contest coffee product (“**Eligible Product(s)**”), including:

1. Original Roast, 925g tin;
2. Rich Dark Roast, 925g tin;

- (ii) log on to www.maxwellhouse.ca and follow the on-screen instructions, including providing your name, phone number, email address, home address with province and postal code, and select your date of birth;
- (iii) agree to the Official Contest Rules;
- (iv) enter the PIN code (“PIN”) found inside the Eligible Product;
- (v) play the Instant Win game;
- (vi) select one of the thirty one NHL® teams (Anaheim Ducks, Arizona Coyotes, Boston Bruins, Buffalo Sabres, Calgary Flames, Carolina Hurricanes, Chicago Blackhawks, Colorado Avalanche, Columbus Blue Jackets, Dallas Stars, Detroit Red Wings, Edmonton Oilers, Florida Panthers, Vegas Golden Knights, Los Angeles Kings, Minnesota Wild, Montreal Canadiens, Nashville Predators, New Jersey Devils, New York Islanders, New York Rangers, Ottawa Senators, Philadelphia Flyers, Pittsburgh Penguins, San Jose Sharks, St Louis Blues, Tampa Bay Lightning, Toronto Maple Leafs, Vancouver Canucks, Washington Capitals, Winnipeg Jets) to follow (“**Selected Team**”)
- (vii) click “Submit”.

After completing the above steps, the Entrant will receive one (1) entry (the “**Entry**”) for the chance to win the Grand Prize and will be immediately entered for the chance to win an Instant Prize.

- (b) **ALTERNATIVE ENTRY:** To enter without purchase, an Entrant must clearly print on a plain piece of paper his/her full name, email address, home address including postal code, phone number, date of birth, Selected Team (as defined above) and an original, hand-written essay no more than five hundred (500) words, no fewer than one hundred (100) words, answering the following question: What is your favourite NHL® team memory? Send to: *Maxwell House* NHL® All-Star Contest, P.O. Box 246, Dept. Maxwell House Canada, Pickering, ONCA L1V 2R4. Envelope must be post-marked during the Contest Period and received by no later than March 31, 2021 (“**Alternative Entry**”). Upon receiving the Alternative Entry, the Sponsor will email the Entrant a PIN via the email address provided. The Entrant may then enter the Contest by following the steps described at section 4(a), using the PIN provided instead of a PIN found in an Eligible Product.

Unless specified, for the remainder of the Official Contest Rules, Regular Entries and Alternative Entries shall be commonly and interchangeably referred to as “**Entry**” or “**Entries**”.

All Entries, whether selected as an Instant Prize Winner or not, are eligible for the Grand Prize Draw. One (1) Instant Prize per selected Entry.

If an Entrant indicates more than one Selected Team on different Entries, the Selected Team indicated on the Entrant's first Entry received by the Sponsor will be deemed to be the Entrant's Selected Team for purposes of the Contest.

5) ENTRY LIMITS: Entries are unlimited per person, per unique PIN, regardless of method of entry.

6) HOW TO WIN:

- a) **GRAND PRIZE WINNER:** One (1) computerized random draw will be conducted by the Sponsor's agent at approximately 12:00 p.m. (EDT) on April 1, 2021 (the "**Draw Date**"), in Southfield, Michigan among all eligible Entrants within the Contest Period ("**Potential Grand Prize Winner**").

- b) **INSTANT PRIZE WINNER:** Three thousand, one hundred (3,100) entry times during the Contest Period have been randomly pre-selected as winning times, with random assignment of prizes to those times. A prize will be revealed to the Entrant whose Entry is submitted at a pre-selected winning time or, if no Entry is submitted at that precise time, to the first Entrant after the pre-selected time. Actual odds of winning Instant Prizes depend on time and date of Entry and the number of actual website visits. Upon playing the Instant Win game and submitting the correct answer to the mathematical skill-testing question, an Entrant will be entered for the chance to win an Instant Prize. Whether the Entrant wins an Instant Prize will be determined immediately. If the Entrant wins a prize, the Entrant will receive an Instant Prize message (the "Prize Message") stating that the Entrant is the potential winner of an Instant Prize (the "Potential Instant Prize Winner"). Entries not selected as an Instant Prize Winner remain eligible for the Grand Prize draw (if received during the Contest Period).

7) HOW TO CLAIM A PRIZE: The Potential Grand Prize Winner shall be notified by email or phone on or about April 2, 2021 (each respectively the "**Notification**"). If a Potential Grand Prize Winner cannot be contacted within three (3) business days of the relevant date of Notification, another Entrant may be selected, at Sponsor's sole discretion.

Upon Notification, within three (3) business days, the Potential Grand Prize Winner is required to: (a) correctly answer a time-limited mathematical skill-testing question without either assistance or mechanical or electronic aid; and, (b) agree to and submit a "Declaration and Release" form ("**Declaration**") confirming, among other things, his/her compliance with these Official Contest Rules and acceptance of the prize as awarded. The guest of the Grand Prize Winner is also required to sign a "Liability and Publicity Release" form.

The Sponsor, in its sole discretion, reserves the right to select another Entrant should a selected Entrant fail to do the aforementioned, or if found ineligible for any reason.

Instant Win prizes will be immediately emailed to each Instant Prize Winner via the email address provided in his/her Entry.

8) ODDS:

GRAND PRIZE: The odds of winning the Grand Prize (defined below) depend upon the number of eligible Entries received during the Contest Period.

INSTANT PRIZE: Instant Win Prizes (defined below) will be randomly awarded during the Contest Period. The odds of winning any Instant Win Prize is 1:806. The odds of winning any specific Instant Win Prize are set out in the list below of Instant Win Prizes. The odds of winning an Instant Win Prize will diminish as Instant Win Prizes are claimed throughout the Contest Period.

9) PRIZES & APPROXIMATE RETAIL VALUES (ARVs): The following prizes are available to be won. All references to money are in Canadian currency.

(a) GRAND PRIZE: There is one (1) “**Grand Prize**” available to be won, which consists of:

- (i)** Two (2) tickets, for the Grand Prize Winner and one (1) guest (the “**Guest**”), to attend (1) 2021 NHL® regular season game of a team of winner’s choice, subject to availability;
- (ii)** Meet and Greet with an NHL® player from team of winner’s choice, subject to availability and scheduling (details to be determined by Sponsor in its sole discretion);
- (iii)** Five-hundred dollars (\$500.00) USD in spending money awarded to Grand Prize Winner;
- (iv)** One (1) round-trip flight (coach class) for the Grand Prize Winner and the Guest, to be used exclusively for the purpose of attending the NHL® regular season game (“**Flights**”). Flights shall depart from the major Canadian airport nearest to the Grand Prize Winner’s residence, as selected by Sponsor;
- (v)** A maximum of three (3) nights’ accommodation for Grand Prize Winner and the Guest in a standard hotel selected by Sponsor (one room, double occupancy) for the sole purpose of attending the 2021 NHL® regular season game (“**Hotel**”); and
- (vi)** A transportation card for Uber, Lyft or equivalent ride hailing service for the Grand Prize Winner in the amount of two-hundred and fifty dollars (\$250.00) USD for transportation to and from the airport, Hotel, NHL regular season game and Meet and Greet (as applicable) (“**Transportation**”).

The total ARV of the Grand Prize is approximately \$6,500.00 CAD. The actual value of the Grand Prize will vary depending on point of departure, airfare fluctuations, and supplier estimates. See **Rule 10 – GRAND PRIZE CONDITIONS AND EXCLUSIONS** for more information.

- (b) INSTANT WIN PRIZES:** There are three-thousand and one hundred (3,100) Instant Win Prizes available to be won. The total ARV for all Instant Win Prizes is thirty-nine-thousand dollars (\$39,000). The number of Instant Win Prizes will diminish as Instant Win Prizes are claimed throughout the Contest Period.

10) GRAND PRIZE CONDITIONS AND EXCLUSIONS:

The Grand Prize Winner and Guest must travel on the same itinerary for the Grand Prize.

Return ground transportation between the Grand Prize Winner’s residence and the departure airport is not included and shall not be provided.

If the Guest of the Grand Prize Winner is a minor in the province or territory where he/she resides, and where the Grand Prize Winner is not the parent/legal guardian of said minor, the minor’s parent(s)/legal guardian(s) must provide written consent as required by the Sponsor to permit the minor to travel as a Guest of the Grand Prize Winner.

If a Grand Prize Winner cannot travel for any reason whatsoever, including, but not limited to: inadequate travel documentation, inability to travel within the specified travel times provided,

inability to travel due to health reasons, etc., at the Sponsor's sole discretion, another eligible Entrant may be selected.

Sponsor reserves the right to revoke the full or partial Grand Prize from Grand Prize Winner or Guest who Sponsor or venue personnel in their sole discretion deem may be: (a) intoxicated; (b) a safety risk; (c) in violation of any venue policy or law; or, (d) bringing the NHL Entities, NHLPA Entities or the Sponsor into disrepute. Sponsor is not responsible if an NHL® game or event is cancelled or postponed for whatever reason. Specifically, if the NHL® regular season game does not occur as scheduled for any reason whatsoever, the Sponsor reserves the right to substitute the Grand Prize with an alternative Grand Prize of equal or greater value.

11) PRIZE SUBSTITUTION: Unless otherwise mentioned in these Official Contest Rules, all prizes available in this Contest are, from now on, collectively referred to as the “**Prize**” or “**Prizes**”, and all respective winners are collectively referred to as “**Winner**” or “**Winners**”. All Prizes available in this Contest must be accepted as awarded. No substitutions or transfers of Prize by any Winner

is permitted. Sponsor reserves the right, in its sole discretion, in the event that a Prize or any component of any Prize cannot be awarded as described for any reason, to substitute or modify the Prize or component with (a) prize(s) of equal or greater value, without liability.

The Winners and Guest are not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any. If the Grand Prize Winner elects to travel through other means not specified herein, no additional compensation will be awarded.

12) ENTRY CONDITIONS AND VERIFICATION: All Entries are subject to verification at any time. The Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor – including, without limitation, government-issued photo identification) to participate in this Contest. Failure to provide such proof to the satisfaction of the Sponsor in a timely manner may result in disqualification.

Any attempt by any Entrant to participate or submit an Entry in any method or to enter or participate in any fashion not sanctioned by the Official Contest Rules will void that individual's Entry and eligibility to win a Prize and the Entrant may be disqualified from the Contest, at the sole discretion of the Sponsor.

Any Entries that are incomplete, illegible, damaged, irregular, have been submitted through illicit means (including, but not limited to, robots or phishing scams), or do not conform to or satisfy any condition of the Official Contest Rules may be disqualified by the Sponsor. Proof of submission does not constitute proof of receipt. Entries that are not fully completed and submitted during the Contest Period will be rejected (in the sole and absolute discretion of the Sponsor). The Releasees (defined below) are not responsible for late, lost, misdirected, delayed, damaged, stolen, incomplete, or incompatible Entries. Entries become property of Sponsor and will not be acknowledged or returned.

13) LIMITATION OF LIABILITY: By entering the Contest, Entrants accept and agree to these Official Contest Rules and the decisions of Sponsor, which shall be final in all matters. Releasees (as defined below) are not responsible for lost or late Entries, the Declaration, or for any typographical or other error in the printing of the offer, failure of the Contest website, administration of the Contest, or announcement of any Prize, or for technical, hardware, or software malfunctions, computer virus, bugs, tampering, unauthorized intervention, fraud, lost or unavailable network connections, or failed, incorrect, inaccurate, incomplete, garbled, or delayed electronic communications, whether caused by the sender or by any of the equipment or programming associated with or utilized in this Contest, or by any human error which may

occur in the processing of the Entries in this Contest, or any other cause beyond the reasonable control of Sponsor that interferes with the proper conduct of the Contest as contemplated by these Official Contest Rules.

The Sponsor, the NHL Entities and the NHLPA Entities extend absolutely no representations or warranties in respect of a Prize and accept no liability arising in respect of such Prize or in the use thereof.

14) RELEASES, WAIVERS, AND DISCLAIMERS:

Unless otherwise required by applicable law, the Entrant agrees to the following releases, waivers and disclaimers:

CONTEST RELEASE: By entering the Contest, Entrants agree to forever release, discharge, and hold harmless, the Sponsor, Promotion Parties, their affiliates, subsidiaries, their advertising and promotional agencies and their respective directors, officers, employees, members, representatives, successors, assigns and agents, parent and related companies, licensors, licensees (collectively, the “**Releasees**”), from and against any and all damages, claims, injuries, death, loss and/or liability to person or property, due in whole or in part, whether directly or indirectly, by the entering and participation in the Contest, including any travel related thereto.

PRIZE RELEASE: If an Entrant wins a Prize and accepts the Prize, such acceptance shall mean full satisfaction of the entitlement as an Entrant and Winner in the Contest and the Entrant fully discharges and forever releases the Releasees, of and from any and all claims, demands, losses, damages, actions, or causes of action whatsoever, whether known or unknown, whether at law or in equity which they or their heirs, executors, administrators, successors, or assigns may now or hereafter have against any of the Releasees in connection with the use, misuse, or otherwise of the Prize.

15) RIGHTS OF SPONSOR: The Sponsor reserves the right, with the consent of the *Régie des alcools, des courses et des jeux*, to terminate, modify, or suspend this Contest or amend the Rules

at any time and in any way, without prior notice or obligation, This includes, without limitation, if for any reason, the Contest is not capable of running as planned or if the administration, security, fairness, integrity, or proper conduct of the Contest is adversely affected. Without limitation, this includes wherein the Sponsor's opinion, there is any suspected or actual evidence of tampering with any portion of the Contest, or if technical difficulties or any other factor including accident, printing, administrative, or any error of any kind compromises the integrity, administration, or conduct of the Contest. It also includes circumstances relating to decisions made by the Promotion Parties about the conduct of the 2020-2021 NHL® Season in response to orders of any provincial government relating to public health.

Any attempt to deliberately damage any website or other component, or to otherwise undermine the legitimate operation of this Contest is a violation of criminal and civil laws and should such an attempt be made, the Sponsor reserves the right to seek remedies and damages to the fullest extent permitted by law, including criminal prosecution.

The Sponsor reserves the right to disqualify a person if he/she enters the Contest or tries to do so by any means contrary to these Official Contest Rules or which would be unfair to other Entrants or where Entries are generated by any mechanical or automated means, including the supply of untruthful, inaccurate, or misleading details or information. Entry materials that have been tampered with, reproduced, falsified, or altered are automatically void. In the event a dispute arises as to the identity of an online potential Winner, Entries made by internet will be declared by the name on the associated online entry form.

All federal, provincial, and local laws and regulations apply. This Contest and the Official Contest Rules shall be governed by, and construed in accordance with, the laws of the Province of Ontario.

16) PUBLICITY: Entering this Contest and accepting a Prize (if applicable) constitutes permission for the Sponsor, and its agencies to use the Entrants', Winners' (and Guest's), as applicable, names, cities, and provinces/territories of residence, biographical information, Entry information, Prize information, video (including video footage of Grand Prize Winner's and Guest's participation in the NHL® experience), recording, voice, photograph, statements, and likenesses for purposes of advertising and publicity in any and all media now or hereafter known throughout the world in perpetuity, without further compensation, notification, or permission, unless otherwise prohibited by law.

By entering this Contest, Entrants consent to Sponsor's collection, use, and disclosure of their personal information for these purposes.
